### **HISTORY**

Although Mississippi Lime was founded in 1907 by Harry B. Mathews Jr., the company has origins as Mississippi Sand Company in Alton, Illinois. Looking to expand, the company purchased property in Ste. Genevieve County, Missouri in the '20s. In the '30s and '40s, Mississippi Lime expanded further and acquired Western Lime Works, Peerless White Lime Co. and Ste. Genevieve Lime and Quarry Co. During the '50s through the '70s, the company experienced growth that required more manufacturing and advanced technology to meet customers' growing needs. This trend continued into the 21st century. In 2001, Mississippi Lime acquired Ash Grove Cement Company in Springfield, Missouri and, in 2003, the company purchased Falco Lime, Inc., located in Vicksburg, Mississippi. A year after the company's 110th anniversary, Mississippi Lime acquired Breen Energy Solutions in 2018. And in 2019, Mississippi Lime acquired Southern Lime in Calera, Alabama. Today, Mississippi Lime continues to be privately held. Our company is guided by our founder's principles and by our vision, mission and values. Today, our headquarters is located in St. Louis, Missouri.
